3b 18-0230 Presentation by PCE on the proposed 10-year Water Supply Plan

The Commission viewed a presentation of the 10 year City of Grand Rapids Water Supply Plan prepared and presented by Naeem Qureshi, P.E. of Progressive Consulting Engineers, LLC. Recommendations of the plan concluded that well and treatment capacity is adequate for the next 10 years, well water levels should be monitored closely, a transducer should be installed in each well to monitor well water levels, and demand reduction measures should be implemented.
